ARTICLE 1 - RECOGNITION AND SCOPE OF THE AGREEMENT

Houston (UP) TX, Lafayette (UP), Baton Rouge (UP), Avondale (UP), and Shreveport (UP) LA added to recognition clause, joining the already existing drivers Houston (BNSF) and Galveston (BNSF) TX and Louisiana BNSF and CN yards and road boards.
